What is the CUMC Foundation?

The Community United Methodist Church Foundation was formed to:

1. Encourage gifts that will become your legacy to carry on the ministry of our church forever.
2. Spend only the interest on your gifts, never the gifts themselves.
3. Enable and grow legacy contributions for the financial support and enhancement of our church's missions.
4. Build a principal fund in excess of \$1 million that will provide perpetual earnings to:
 - Maintain and improve our current facilities
 - Develop programs that enhance our religious and educational activities
 - Provide for emergencies and unanticipated needs of CUMC
 - Make funds available for local community outreach programs

CUMC's Charge Conference has given the Foundation Board of Directors the task of building an endowed Foundation Fund of more than a million dollars. The purpose of the fund is to perpetually earn income which will be used to further the Mission Statement of our church. How Do I Make a Gift?

There are many ways to make charitable gift contributions and reduce your taxes. A member of the Foundation Board will be happy to assist you.

1. Provide a legacy gift by specifying in your Will or Trust that the CUMC Foundation is to be the recipient of a portion of your estate. There are attorneys, among our members, who are willing to help with questions about Wills and Trusts.
2. Provide a legacy gift by designating the CUMC Foundation as the beneficiary of life insurance policies that have served their past purposes and are available for the future of your family and friends in Christ.
3. Make a tax deductible lump sum contribution of money or stock by contacting the church treasurer or financial secretary.
4. Add a little more to your Sunday offering. Use your regular offering envelope or one found in the pew racks, and designate on the envelope the amount you want to go to the Foundation.
